<p><u>Registration/Rules Meeting</u></p> <p><u>Location:</u> Hiawatha Beach Resort 10904 Steamboat Loop NW Walker, MN. 56484</p> <p><u>Date:</u> Friday, September 25, 2020</p> <p><u>Registration Times:</u> 6:00 p.m. – Registration Opens 7:00 p.m. – Registration Closes. 7:15 p.m. – Mandatory rules briefing begins.</p> <p>All anglers must be off the water by 3:00 p.m. on the day of the rules meeting.</p>	<p><u>Launch/Weigh-In</u></p> <p><u>Location:</u> Hiawatha Beach Resort</p> <p>Take-off will begin at 7:00 a.m. or first safe light.</p> <p>Weigh-in starts at 3:00 p.m.</p> <p>Sunrise 09/26/2020 – 7:12 a.m. Sunrise 09/27/2020 – 7:13 a.m.</p> <p><u>Site Hosts</u></p> <p>Minnesota Bass Federation & Walker, MN.</p>	<p><u>Required Items and Safety Equipment</u></p> <p>It is the responsibility of each participant to have ALL required state and federal safety equipment on board as well as, ALL permits licenses, passes or stamps, Etc. required.</p> <p>At time of inspection each morning, be prepared to properly display 1 life jacket for each angler; 1 throwable PFD; and, demonstrate functioning kill switch.</p> <p>Inspection will be held during lineup for takeoff. Live wells must be empty.</p> <p>All anglers are required to have a valid Minnesota fishing license.</p>
<p><u>Fish Limits</u></p> <p>Largemouth Bass ONLY 12" inches and over.</p> <p>Anglers are allowed to weigh a limit of five (5) fish per person unless otherwise required by law or tournament officials</p> <p>Any fish presented for weigh-in which fails to measure the official length limits shall accrue penalties at the rate of one (1) pound for each non-legal fish plus loss of the fish. Saturday and Sunday are competition days (Read the rules)</p>	<p><u>Boundaries</u></p> <ul style="list-style-type: none"> - County Road 38 bridges on Kabekona River & between Kabekona Bay (Leech Lake) and Benedict Lake. - County Road 50 bridge on Shingobee Creek. - State Highway 371 bridge on the Steamboat River. - County River 8 bridge on the Boy River. <p>Any waters within these boundaries posted "off limits" or "no fishing" by state or federal agencies will be off limit. Any live release areas established by the Tournament Director will be off limits. That as well as any additional off limits will be announced at the pre-tournament briefing. Only that water open to all public fishing will be considered tournament waters. Any waters closed to public fishing will be closed to this tournament's contestants. All local, state and federal regulations apply.</p>
