<p><u>Registration/Rules Meeting</u></p> <p><u>Location:</u> Quality Inn 6169 Reve Court Fort Madison, IA 52627</p> <p><u>Date:</u> Friday, October 8, 2021</p> <p><u>Registration Times:</u> 4:00 p.m. – Registration Opens 6:00 p.m. – Registration Closes. 6:15 p.m. – Mandatory rules briefing begins.</p> <p>All anglers must be off the water by 3:00 p.m. on the day of the rules meeting.</p>	<p><u>Launch/Weigh-In</u></p> <p><u>Location:</u> Willow Patch Ramp Fort Madison, IA Located on Avenue G - up river of the Fort Madison toll bridge.</p> <p>Take-off will begin at 7:15 a.m. or first safe light.</p> <p>Weigh-in starts at 3:00 p.m.</p> <p><u>Site Hosts</u></p> <p>Illinois Bass Federation & Fort Madison, IA.</p>	<p><u>Required Items and Safety Equipment</u></p> <p>It is the responsibility of each participant to have ALL required state and federal safety equipment on board as well as, ALL permits' licenses, passes or stamps, Etc. required.</p> <p>At time of inspection each morning, be prepared to properly display 1 life jacket for each angler; 1 throwable PFD; and, demonstrate functioning kill switch.</p> <p>Inspection will be held during lineup for takeoff. Live wells must be empty.</p> <p>All anglers are required to have either a valid Iowa or Illinois Fishing license. Anglers will need to have an Iowa fishing license if fishing past bridges on Iowa side.</p>
<p><u>Fish Limits</u></p> <p>Largemouth and smallmouth Bass 14" inches and over.</p> <p>Anglers are allowed to weigh a limit of five (5) fish per person unless otherwise required by law or tournament officials</p> <p>Any fish presented for weigh-in which fails to measure the official length limits shall accrue penalties at the rate of one (1) pound for each non-legal fish plus loss of the fish. Wednesday, Thursday, and Friday are practice days. Saturday and Sunday are competition days (Read the rules)</p> <p>Any waters within these boundaries posted "off limits" or "no fishing" by state or federal agencies will be off limit. Any live release areas established by the Tournament Director will be off limits. That as well as any additional off limits will be announced at the pre-tournament briefing. Only that water open to all public fishing will be considered tournament waters. Any waters closed to public fishing will be closed to this tournament's contestants. All local, state and federal regulations apply.</p>
