# Registration/Rules Meeting/Banquet DO NOT BRING YOUR BOATS to Registration

Tuesday, July 25th, 2023

#### **Registration Times:**

4:00 p.m. – Registration Opens 5:00 p.m. – Registration Closes. 5:15 p.m. – Mandatory rules briefing begins. Diner banquet begins

No teams are allowed to be on the water without TD approval after 3:00pm on Registration Day.

#### **Fish Limit**

12" or over for all bass for this Junior youth event by permit.

Team may weigh a limit of five (5) fish per day.

Fish presented which fails to measure the official length limits shall accrue penalties at the rate of one (1) pound for each non-legal fish plus loss of the fish. An 8-ounce deduction will be made for each fish presented that is determined to be non-releasable.

#### Launch/Weigh-In

Sooner Lake, Highway 177 south of Ponca City - OG&E Power Plant Lake. Ramp is west of the Corner of US Hwy 177 and OK 15 south of OG&E power plant

Take-off will begin at 6:00 a.m. or first safe light thereafter each day.

Weigh-in begins: 2:30 p.m.

#### **Required Items and Safety Equipment**

It is the responsibility of each participant to have ALL required state and federal safety equipment on board as well as, ALL permits' licenses, passes or stamps, etc. required.

At time of inspection each morning, be prepared to properly display 1 life jacket for each angler; 1 throwable PFD; and, demonstrate functioning kill switch.

Inspection will be held during lineup for takeoff. Live wells must be empty.

Non-Residents of Oklahoma 14 and older are required to have a valid Oklahoma fishing license/permit if so required.

# All event functions (Tuesday Registration, Thursday pool party, pizza party) everything will take place in Ponca City.

A final schedule of events will be sent to each team after Preregistration closes.

# **Boundaries**

### Sooner Lake Only.

Any waters within these boundaries posted "off limits" or "no fishing" by state or federal agencies will be off limits. Any live release areas established by the Tournament Director will be off limits. That as well as any additional off limits will be announced at the pre-tournament briefing. Only that water open to all public fishing will be considered tournament waters. Any waters closed to public fishing will be closed to this tournament's contestants. All local, state and federal regulations apply.

## **NOTICE:**

**This is a TEAM event**, 2 anglers, 8<sup>th</sup> grade and under the day they qualified and (1) volunteer boat captain 19 years old or older to each boat. Three (3) people are required in every boat. **NO exceptions.** 

**PRE-TOURNAMENT PRACTICE:** The JWC waters will go off-limits at Sundown on Sunday July 9<sup>th</sup> until the first official practice day on Monday, July 24<sup>th</sup> (the MONDAY before the first competition day). **YOU MAY NOT have anyone practicing for you during the off-limits time.** There will be two (2) designated practice days. If you choose to practice either of these two (2) designated practice days, the Junior team and the registered boat captain must do so from the same boat. The two (2) designated practice days shall be Monday and Tuesday, July 24, 25 ONLY. All anglers must be off plane and in sight of the launch ramp, no longer fishing and getting off the water by 3:00pm local time on Tuesday, July 25<sup>th</sup> prior to on-site registration. The lake will go back off-limits to all competitors at that time except for official tournament hours.
