Live wells must be empty.</p> <p>Anglers are required to have a valid Arkansas fishing license/ permit, if applicable by law.</p>
<p align="center"><b><u>Fish Limits</u></b></p> <p>Largemouth, smallmouth &amp; spotted Bass 14" inch minimum</p> <p>Anglers are allowed to weigh a limit of five (5) fish per team unless otherwise required by law or tournament officials.</p> <p>Fish presented which fails to measure the official length limits shall accrue penalties at the rate of one (1) pound for each non-legal fish plus loss of the fish. An 8-ounce deduction will be made for each fish presented that is determined to be non-releasable.</p>	<p align="center"><b><u>Site Host</u></b></p> <p>Russellville Tourism &amp; Visitors Center 110 S. Only that water open to all public fishing will be considered tournament waters. Any waters closed to public fishing will be closed to this tournament's contestants. All local, state and federal regulations apply.</p>
