Weigh-in starts at 3:00 p.m. Day 1 Weigh-in starts at 2:00 p.m. Day 2 Site Hosts Georgia Bass Federation & Cordele-Crisp Chamber of Commerce, GA	It is the responsibility of each participant to have ALL required state and federal safety equipment on board as well as, ALL permits' licenses, passes or stamps, as required. Life Jackets Save Lives. At time of inspection each morning, be prepared to properly display one (1) life jacket for each angler; one (1) throwable PFD; and demonstrate functioning aerated system and kill switch. Inspection will be held during lineup for takeoff. Live wells must be empty. All anglers are required to have a current Georgia Fresh Water Fishing License.
Fish Limits	Tournament Director	Boundaries
Largemouth Bass must be over 14 inches; Spotted Bass must be over 12 inches; Shoal Bass must be over 15 inches. Anglers are allowed to weigh a limit of five (5) fish per person unless otherwise required by law or tournament officials. Any fish presented for weigh-in which fails to measure the official length limits shall accrue penalties at the rate of one (1) pound for each non-legal fish plus loss of the fish. An 8-ounce deduction will be made for each fish presented to the bump master for weighing that is determined to be non-releasable. Wednesday, Thursday, and Friday are practice days. Saturday and Sunday are competition days (Read the rules) Any waters within these boundaries posted "off limits" or "no fishing" by state or federal agencies will be off limit. Any live release areas established by the Tournament Director will be off limits. That as well as any additional off limits will be announced at the pre-tournament briefing. Only that water open to all public fishing will be considered tournament waters. Any waters closed to public fishing will be closed to this tournament's contestants. All local, state and federal regulations apply.
